



TERMS AND CONDITIONS OF ENTRY INTO 2021 JJ DRESSER & CO

CALENDAR PHOTO COMPETITION (THE PROMOTION)

1. Information on how to enter forms part of these terms and conditions. If there is any inconsistency between these terms and conditions and any other published information, these terms and conditions will prevail to the extent of the inconsistency. By participating in this Promotion, each participant fully and unconditionally agrees and acknowledges that these terms and conditions are binding.

3. The Promotion commences at 9am on Monday 6 July 2020 and closes at 5pm on Friday 14 August 2020
4. This Promotion is a game of skill. Chance plays no part in determining the winner. Each entry will be judged by a panel of judges (Judges), nominated by JJ Dresser & Co, according to its merits as determined by the Judges in their sole discretion.
5. Photographs previously entered for any competitions held by us are not eligible
6. Entry is open to all residents of Australia who submit a valid entry in accordance with clause 7 during the Promotion Period ("an Eligible Entrant"). Judges and their family members are ineligible to enter.
7. A maximum of twenty (20) entries is allowed per person.
8. Entries can only be submitted electronically via email to competition@jldresser.com.au
9. There are no age restrictions on entry
10. Entries must contain the following information:
Entrant's full name, the location of where the photograph was taken, Entrant's postal address, email address and preferred telephone contact number
11. Photographs can be submitted in a range of digital formats (eg JPEG, TIFF) but must be high resolution at A4 size 300 dpi.
Photographs should not be downsized or compressed for email. Photographs may be edited, prior to entry only, to adjust 'errors' in composition, exposure, brightness and contrast, however content must not be removed, added, altered or distorted beyond the truth of the original photograph
12. The only alterations permitted to photographs entered in the competition are cropping and rotation eg to straighten a crooked horizon
13. No deletions can be made to submitted entries.
14. Merit will be awarded based on image composition (sharpness, balance and light) artistic and creative imagery.
15. Consideration will be given as to how the image captures the spirit of local farming.
16. JJ Dresser's decision in relation to any aspect of the competition will be final and binding on every person who enters. No correspondence will be entered into.

17. No responsibility will be accepted by JJ Dresser for lost or late entries.
18. By submitting an entry to the Competition, each entrant agrees that:
 - he/she has obtained prior consent to be depicted in the entry, from any person or property appearing in the image;
 - he/she has obtained prior consent to be depicted in the entry, from the legal parent/guardian of any minor appearing in the image;
 - he/she has obtained full prior consent from any person who has jointly created or has any rights in the image, to the uses and terms herein
 - the electronic file containing the entry does not contain any viruses or trojans and will not cause injury or harm to JJ Dresser & Co's computer systems;
 - he/she has complied with all applicable laws and regulations, including without limitation, those governing copyright, content, defamation, privacy, publicity and the access or use of others' computer or communication systems;
 - he/she is the legal owner of the image they submit; and
 - he/she indemnifies JJ Dresser & Co, to the full extent permitted by law, against any loss arising out of the use of the image in association with the Competitions rules
